


# St. Patrick's Cemetery Interments and Disinterment

### **Interments**

- 1. Arrangements for burials shall be made at the Cemetery office. Burials will not be made on Sundays, Holy Days or Legal Holidays.
- 2. A proper burial permit, issued by a duly accredited public official, must be presented to the Cemetery before burial can be made. Payment for the grave opening must also be paid before the burial.
- 3. Location for the interment on multiple grave lots should be made by the family or its representatives.
- 4. Concrete or metal outer cases (vaults) must be used for an adult interment in the Cemetery. Such outer cases must not exceed the Cemetery's standard grave dimensions and regulated size.
- 5. All adult burials must be made with a casket. Caskets must be firm enough to be properly carried to the grave and rigid enough to be handled on a standar lowering or handling device. Sealed caskets are not required.
- 6. Cremated human remains for in-ground burial must be placed in a concrete outer container or in a Urn Vault unit, but not in a plastic container.
- 7. The following may be buried in one grave:
  - 1 full body
  - 1 full body and 1 cremated human remains
  - 1 full body and 1 infant
  - 2 cremated human remains
  - 2 infants
- 8. Funerals should follow Cemetery traffic directions and proceed via the driveway on the left. All vehicles should remain on the paved roads and never drive on the grass.
- 9. The casket may not be opened at any time within the Cemetery without the express permission and in the presence of the management. The Management reserves the

right to refuse permission to any one to open the casket or to touch the body without the consent of the legal representative of the deceased or without a Court order.

- 10. Only persons employed by St. Patrick's Cemetery or Parish, and only equipment owned by the Cemetery contractor shall be used in making burials or removals unless the Management makes other arrangements.
- 11. Besides being subject to the Rules and Regulations, all burials shall be subject to the orders and laws of the State of New York, the County of Ontario, and the Town and Village of Victor.

### **Disinterment**

- 1. Application for disinterment of a body shall be made at the Cemetery office. Permission for disinterment must be based upon application of the spouse, child or children, parent or parents, next of kin or designated person responsible for the deceased person.
- 2. In certain cases, the Cemetery may require a Court order to allow the removal.
- 3. Upon proper application and payment for the disinterment, the Cemetery will schedule the removal, either for movement from one part of the Cemetery to another or removal to another cemetery.
- 4. During disinterment, the casket will not be opened for any purpose without a Court order. A licensed funeral director must be present when a body is to be moved within the Cemetery or to another cemetery.
- 5. At the time when arrangements for disinterment are made, arrangements must also be made for the removal of any and all monuments and headstones pertaining to the body from the Cemetery. If the disinterment is for the purpose of moving the locations of the body within the Cemetery, and the memorial meets the monument regulations of the new location, the family must make arrangements to have the monument reset at the time the disinterment arrangements are made.
